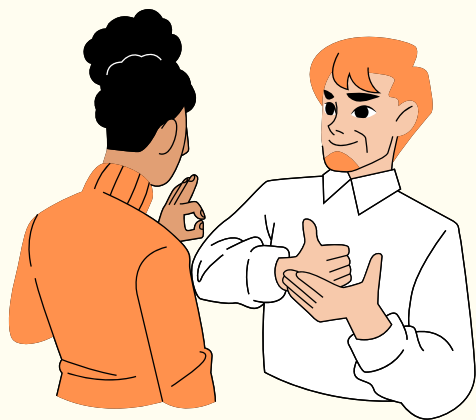

MESSAGE FROM MS. MADHU SINGHAL

FOUNDER AND MANAGING TRUSTEE

I would like to start by wishing you all a safe and healthy life. Last year was a very crucial year for all of us, as the Covid-19 pandemic started in January 2020 in India and at that time no one had any idea how things would turn out and what the future would be like. When the Government of India declared a national lockdown in the middle of March 2020, we were all forced to follow a work-from-home strategy, which was entirely a new approach for NGOs like Mitra Jyothi. During the entire period of the first stage of lockdown, we tried to continue our support for PWDs remotely. On 4th May, when the lockdown restrictions were relaxed, Mitra Jyothi's staff started coming to the office following all the Covid protocols and restarted our regular work. We started sending Braille books and magazines to our beneficiaries.

Last year, we distributed many Braille textbooks to many schools and completed two regular computer training courses and one online course for the previous batch. Even though 2020 was a difficult year for everyone, Mitra Jyothi's staff worked hard and contributed significantly to meeting the needs of people with disabilities in general and the visually impaired in particular.

I would also like to bring to your kind notice that we have lost some of the friends and well-wishers of Mitra Jyothi due to COVID-19. I would like to especially mention the names of Mr. P K Pincha, the former Chief Commissioner for Persons with Disabilities, and Mr. A K Mittal, Ex-Director, NIEPVD, and president of the All India Confederation of the Blind. I have learned a lot from both of them and their demise is a great loss for us. On behalf of Mitra Jyothi, I convey our heartfelt condolences to their family members.

In spite of the pandemic situation, we did receive a few recognitions this year as well, like the True Torch Bearer Award from KN Groups and a few recognitions on occasion of Women's Day celebrations from Samarathanam, Lions club & KWEAB. As a concluding remark, I would like to thank all our well-wishers, donors, staff, volunteers, and beneficiaries; and we expect the same kind of cooperation in the future. We will complete many more years like this, despite many difficulties that we may come across. We will stick to our vision and mission to fulfill the needs of our PwD (Persons with Disabilities) beneficiaries.

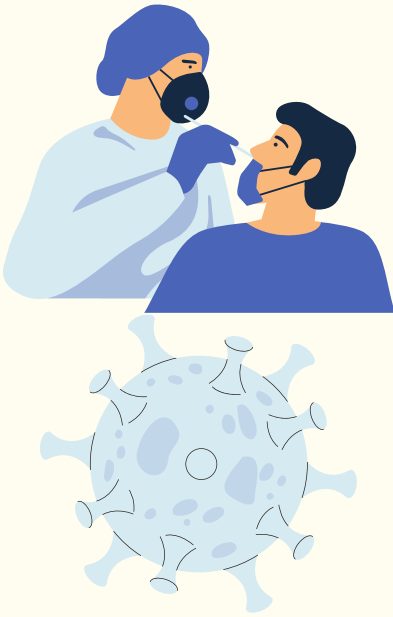

HIGHLIGHTS OF THE YEAR

COVID - 19 AWARENESS PROGRAM FOR THE VISUALLY IMPAIRED



The COVID - 19 pandemic, which was followed by a nationwide emergency lockdown, had a significant impact on everyone, particularly those with visual impairments.

Due to the restrictions imposed by the government as a safety measure, Mitra Jyothi's services were slightly hindered in the early days of the lockdown.

Soon after the WHO declared the pandemic, the Mitra Jyothi team took part in an online COVID - 19 awareness campaign for the visually impaired. Materials for raising awareness were created by the team with the aid of a medical professional and then published online for the benefit of others.

STAFF ENABLEMENT PROGRAM - 'SEARCH INSIDE YOURSELF'



Our team participated in a two-day training session titled "Search Inside Yourself," which focused on self-enablement.

This mindful leadership training has been shown to lower stress, improve concentration and work performance, as well as improve wellness and resilience.

There were also trainees from Winwinaya Foundation, Cheshire Disability Trust, and Sampark, in addition to Mitra Jyothi employees.

THE INDIA YEAR BOOK 2020 WAS PROVIDED IN AN EASILY ACCESSIBLE FORMAT FOR COMPETITIVE EXAMS



The ePub version of India year book 2020 made available at Mitra Jyothi Library and Sugama Pusthakaalaya for the benefit of Visually Impaired beneficiaries who are preparing for competitive exams.

PROVISION OF ACCESSIBLE TEXTBOOKS FOR THE KARNATAKA TEXT BOOKS SOCIETY (KTBS) FOR CLASS VI TO CLASS X STUDENTS

For KTBS, the Mitra Jyothi team translated Text Books from class VI to X standard into EPUB format. The same is available on the KTBS website for academic purposes to the students. This year, the team even created DAISY versions of mathematics textbooks for students in grades VI and X.



STATIC GK A LIMITED-EDITION BOOK MADE AVAILABLE IN A VARIETY OF FORMS

The Mitra Jyothi team gathered material about static GK from many sources and developed a book in braille, DAISY, and ePub formats for the benefit of Visually Impaired UPSC candidates with the help of a volunteer: Amrutha



INDEPENDENT SHOPPING EXPERIENCE HOSTED BY THE HOUSE OF PRIMES AT MITRA JYOTHI

Mitra Jyothi takes pleasure in partnering with volunteer/corporate projects in the pursuit of a more inclusive society.

The Mitra Jyothi team organized an event in partnership with House of Primes to provide residential students with an all-inclusive shopping experience. The essential information on the garment labels and tags was written in braille, allowing pupils to understand it and choose an outfit depending on their preferences.

Students were requested to choose and bring a certain color, brand, and size dress from the assortment presented to make the event more effective. The findings were even used to award prizes.



B S MALA, A 20-YEAR BENEFICIARY OF MITRA JYOTHI'S TALKING BOOK LIBRARY (TBL), NOW HOLDS A DOCTORATE.



This year, B S Mala received her Ph.D. from Mysore University, which we are extremely proud of. From her SSLC until her Ph.D., Mala has relied on Mitra Jyothi's assistance.

Mala looked through Mitra Jyothi's TBL not just for academic works, but also for other literary genres. Finally, when Mala received her Ph.D. in 2020, she became a symbol of self-assurance, motivation, and inspiration, as well as a ray of hope for many individuals who still feel that physical disabilities may prevent them from achieving their goals in life.

PROGRAM SUMMARY



BRILLE TRANSCRIPTION CENTRE

- 5700 braille book copies, totaling over 8 lakhs braille pages, were printed and distributed.
- Supported over 20 schools and thousands of individuals across India.

AUDIO / DIGITAL LIBRARY

- A total of 278 accessible books with a total of 43997 pages were developed.
- 3709 audiobook copies distributed via CDs, plus thousands of downloads via online sources.


PUBLICATIONS

- Spardha Shrunkala and Industry Mitra audio titles were produced and disseminated in 16 issues.
- 16 issues of Jnaana Samhita and Insight braille magazines were printed and distributed, totaling 1500 copies.

HIGHER EDUCATION SUPPORT

- Five visually impaired females were identified and provided with educational assistance as well as a dormitory.
- Personality development, signature training, mathematics, and communication workshops were also provided to the students in order to improve their employability.

TRAINING AND PLACEMENT ASSISTANCE

- This year, more than 70 visually impaired recipients were enabled through residential computer and life skills training.
 - Around 15 individuals had completed computer training via the internet.
 - Despite the pandemic challenges, 100+ individuals with impairments registered for placement assistance, and 22 were placed under various professions.

OVERVIEW OF THE EVENTS

HELEN KELLER DAY - A STAFF AWARENESS EVENT



The day honors the life and accomplishments of Helen Keller, an American activist, and novelist, and is commemorated every year on June 27. We held an event this year to teach the staff of Mitra Jyothi how to detect words by lip-reading because a few of them were new to the disability sector.

WHITE CANE DAY - A PUBLIC AWARENESS CAMPAIGN



Mitra Jyothi's staff and students marched together on 27th Main road near NIFT college as part of White Cane Safety Day to raise awareness among the general public in the HSR layout area. It was primarily to demonstrate the value of a white cane and how to use one and how it can aid visually impaired people to commute with confidence.

Another highlight of this year's event was our team's demonstration of how to guide visually impaired people with social distance in a pandemic situation. A few sighted employees were blindfolded and guided to walk with the aid of a white cane by others.

STUDENT VISIT BY OXFORD COLLEGE - AWARENESS FOR COLLEGE STUDENTS



Twenty students along with two faculties from Oxford College came to Mitra Jyothi for an orientation visit. The main objectives of the orientation visit were to get an overview of the organization's activities and to help the students to gain insight on how to deal with persons with disabilities. Also, it was an exposure for the students to understand the organization structure, CSR concept, and various other aspects from an NGO perspective.

CHRISTMAS CELEBRATIONS A VISUALLY IMPAIRED BENEFICIARIES AWARENESS EVENT

During the Christmas event hosted by Xebia IT Architects India Pvt Ltd at Mitra Jyothi, Santa Claus brought even more smiles and cheers.

The event included music and dance, as well as gifts from the firm. Many students said it was a once-in-a-lifetime experience for them, and they took photos with Santa to cherish it.



WORLD BRAILLE DAY - AN AWARENESS QUIZ FOR THE STAFF AND STUDENTS

On January 4, 2021, Mitra Jyothi, along with its students and staff, commemorated World Braille Day.

Ms. Madhu talked about Louis Braille and how he helped millions of people who are blind or visually impaired. To raise awareness and provide information on Louis Braille, a quiz was administered to Mitra Jyothi students and employees.



THE INTERNATIONAL DAY OF INDIVIDUALS WITH DISABILITIES A COMMUNITY AWARENESS EVENT

The Mitra Jyothi Trust partnered with the Department of Psychology at St Aloysius College Mangaluru to host a disability awareness program. In her speech, Ms. Madhu Singhal highlighted the outstanding contributions provided by so many pioneers who were essential in campaigning for a more inclusive society. Mr. Danish Mahajan, the founder of Radio Udaan, an inclusive online radio station for individuals with disabilities stated that accepting one's impairment and focusing on chances can assist a person with a disability achieve his or her goals. The Mitra Jyothi team organized a disability awareness month in November 2020, with events scheduled every Thursday. The festivities were attended by students, employees from Mitra Jyothi, and 31 students from St Aloysius College Mangaluru. Pick & Speak, Debate, Antakshari, and a memory game were among the competitions. We feel we have successfully achieved our goal of raising disability awareness through inclusive competitions and recreation. On December 3rd, the winners' names were announced, and prizes and certificates were awarded.



DEMONSTRATION OF PRODUCTS FROM ENABILITY FOUNDATION AN ASSISTIVE PRODUCTS AWARENESS EVENT



Enability Foundation for Rehabilitation is a non-profit organization dedicated to providing assistive technology solutions to society's marginalized and disadvantaged individuals. They create various assistive technologies to promote inclusive education and development. Enability foundations sent a representative to Mitra Jyothi to demonstrate technologies like Take Note and tactile copies printed through Tactograph.

INTERACTIVE DISCUSSION ON LEGAL AWARENESS AND THE RPD ACT LED BY MR. ARUN FROM THE VOICE OF NEEDY FOUNDATION



Mr. Arun Kumar from the Voice of Needy Foundation came to Mitra Jyothi to address the students about the RPD Act of 2016 and his own experiences. Throughout the discussion, he focused on the importance of human rights for individuals with impairments (RPD Act). He touched on the right definition of disability, rehabilitation for impairments, and the history of the RPD Act from 1995 to 2016. In a nutshell, he described how difficult the situation was for individuals with disabilities in the past and how the act was revised to improve the situation for individuals with disabilities today. It was an eye-opening event for the students, and they asked several questions regarding the material discussed.

HEALTH AND HYGIENE - AN AWARENESS WORKSHOP HELD AT MITRA JYOTHI ON 10TH MARCH 2020



Every three months, Mitra Jyothi organizes a workshop on "Health and Hygiene" for the beneficiaries to raise awareness. Mrs. Rekha, a specialist in this field, has been covering this issue for Mitra Jyothi beneficiaries for a long time. She spends a lot of time in the session talking about "Health and Hygiene" and "Family Planning." She also goes through the essential precautions to take in order to live a healthy life. These lessons are critical for visually impaired individuals to lead a comfortable life.

VALEDICTORY CEREMONY - COMPUTER TRAINING STUDENTS

On December 30, 2020, the valedictory ceremony for the 37th batch of computer training took place. The three-month computer training comprised a variety of lessons, and the students were encouraged by motivational presentations and other initiatives organized by the Mitra Jyothi team for their benefit during the course.



INTERNATIONAL WOMEN'S DAY CELEBRATION - 8TH MARCH 2020

The Mitra Jyothi team, as always, celebrated International Women's Day. On the occasion of International Women's Day, a group of eight individuals from the Human World Foundation paid a visit to Mitra Jyothi. They enjoyed an interactive session with a few Mitra Jyothi students and staff members, and they were given an overview of Mitra Jyothi's programs.



The most memorable event of the day for us was when our student Anneyamma, who is in her second year of B.A. at Govt College Agara, joined the NSS team and participated in a rock climbing activity at Kanteerava Stadium. Anneyamma has been a resident of Mitra Jyothi for four years. She came for computer training and was accepted into a neighboring PU college and later a degree institution. Anneyamma demonstrated that physical restrictions are irrelevant if you have the desire and determination to succeed in life. Mitra Jyothi's contentment and success are built on the achievements of individuals like Anneyamma.




ONLINE AWARENESS EVENTS

Mitra Jyothi used to create awareness by visiting Corporate offices, NGOs, and educational institutions.

Unlike prior years, several corporations' lockdown restrictions and work-from-home strategies limited our field visit activities this year. However, we were able to run a few awareness campaigns employing online platforms.





During the pandemic, an online session with the Guide Runners India team was held in June 2020 to guide the pan-India team in providing emergency assistance and serving as a phone buddy for visually impaired individuals.

In June 2020, the All India Confederations of the Blind hosted an online awareness session on reproductive health.

During Covid-19, the University Law College and Department of Studies in Law, Bangalore University, hosted an international virtual workshop on rights for individuals with disabilities in August 2020, and the Mitra Jyothi team increased awareness among prospective law graduates through the event.

A virtual session with the Accenture team as part of a town hall meeting for all employees in Data and AI technologies during September 2020.


On the occasion of White Cane Safety Day in October 2020, a disability awareness session was held for members of Sahodaya, St Aloysius College (Autonomous) Mangalore.

Ms. Madhu Singhal from Mitra Jyothi spoke as a role model and motivational speaker at the Rotary Bangalore Abilities Communications, Leadership, Abilities, and Personal Growth (CLAP) Awareness workshop on the topic "Leading Others Boldly" in October 2020.

Participated and raised awareness in an event "The Qs on Employment organized by LV Prasad Institute during February 2021.

In February 2021, the 1M1B team has conducted an online awareness session with "Capgemini" personnel.

Ms. Madhu Singhal shared her life story during a March 2021 online webinar hosted by the Composite Regional Centre for Skill Development, Rehabilitation, and Empowerment of Persons with Disabilities (CRC), Lucknow.

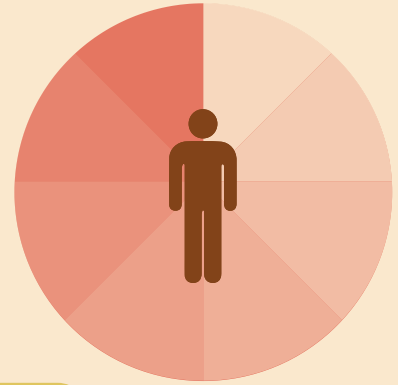
